RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely, POONAMCHAND GUPTA VOCATIONAL COLLEGE, RUN BY THE NIMAR EDUCATION SOCIETY, CIVIL LINES, KHANDWA, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED) course vide order dated 29.08.2008 for an annual intake of 100 students.

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since, the institutions are existing institutions, the inspection was to be conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 19.01.2015.

AND, WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 31.05.2015.

AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...Follow up of Revised Orders for B.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 10.08.2016 and reply of compliance received on 05.10.2016.

AND WHEREAS, the matter was placed in 280th Meeting held on August 31st September 01st, 2017 of WRC and the Committee decided that "...Show Cause Notice was issued to the institution on 10.08.2016 regarding approved staff list, FDRs, Building Completion Certificate and CLU. The institute has not given any reply till date.

Hence, Recognition is withdrawn from the session 2018-2019, FDR, if any, be returned."

AND WHEREAS, the Withdrawal Order issued on 19.09.2017. The institution filed a appeal to the appellate authority Hqrs. no. APPL11994 dated 12.10.2017. Regulatory file sent to Hqrs. on 01.12.2017.

AND WHEREAS, the appeal order dated 13.02.2018 the Council hereby remands back the case Poonamchand Gupta Vocational College, Civil Lines, Khandwa, Madhya Pradesh to the WRC, NCTE for necessary action as indicated above.

AND WHEREAS, the matter was placed in 292nd Meeting held on May 15 - 17, 2018 of WRC and the Committee decided that "...This is a case of appeal. Appellate Authority vide order dated 13.02.2018 has remanded the case to WRC to re-examine the case. The WRC examined the letter of the institution dated 30.09.2016 and found that there is a staff profile of one Principal and 15 faculty members, which is approved by the Registrar.

FDRs for Rs.12.00 lakhs in joint account not submitted in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

AND WHEREAS, the clarification letter issued on 21.05.2018 and reply of received on 01.06.2018.

AND WHEREAS, the matter was placed in 293rd Meeting held on June 12 - 14, 2018 of WRC and the Committee decided that "...Compliance letter was issued to the institution on 21.05.2018 regarding submission of FDRs of 12 Lakhs in original. The institute replied on 01.06.2018 enclosing FDRs for 7 & 5 lakhs.

Hence, Recognition is restored and permitted to continue."

NOW THEREFORE, the recognition of POONAMCHAND GUPTA VOCATIONAL COLLEGE, RUN BY THE NIMAR EDUCATION SOCIETY, CIVIL LINES, KHANDWA, MADHYA PRADESH for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) is hereby revived.
